#### REPORTS

a. Police Report – Scott Barrett

- Mr. Barrett presented his report. There was a total of 49 complaints handled by the CLPD, in addition to 18 traffic stops. CLPD traveled 805 miles and used 91.8 gallons of fuel.

b. DPW Report – Sam Mullens

- Mr. Mullens presented his report. Mr. Mullens highlighted that Olstrom will be patching the hole on Old State were the water lines were repaired. He also talked about the 07 plow truck needing repairs for its belly blade.

c. Campground Report – Kathy Patton

- Mr. Brian Patton presented the campground report. This year the campground was up \$13,957 in revenue, despite opening a month later. Mr. Patton also discussed that the campground will be instituting rule changes for next year, would like to plant 7 - 10 trees, need to relocate main WiFi Box, and need to decide on a registration software by December 15, 2020.

   questions from the board on the current software and improvements this software
   would create.

OLD BUSINESS:

- a. New Pavilion
  - There was discussion on ponding in the new pavilion, along with different solutions to fix the problem.
- b. Waste Water USDA Bond President Rob Tyler presented a packet to the council members concerning the need for a new sewer system. The village has submitted an application to the USDA for the bond, with an interest rate not to exceed 1.175% for 40 years.
- c. Noxious Weed Ordinance Mr. Ralph Hines discussed the noxious weed ordinance. There was much discussion between all the members of the council. It was decided that the council will revisit this next month.

### PUBLIC COMMENT

 Mr. Tom Underhill talked about the noxious weed ordinance. Mr. Underhill stated that the state passed its first noxious weed ordinance 79 years ago. He believes that the village ordinance needs to be rescinded or at least remove the 8" in height portion of the ordinance
